Re.: Important Notice: Select Investment Series III SICAV – Changes affecting several funds

Dear Shareholder,

We are writing to inform you of the following changes made to the prospectus of the Select Investment Series III SICAV (the “Company”) in the October 2024 update:

1. With effect from 1 December 2024, the T. Rowe Price Global Focused Growth Equity Fund will be renamed T. Rowe Price Global Focused Growth Equity Net Zero Transition Fund, following a change to its investment policy that, as from the effective date, foresees that the promotion of environmental and social characteristics is done through the fund’s commitment to reduce the carbon footprint of the portfolio over the long-term, thereby contributing towards the goals of limiting global warming to 1.5° C. The fund will also maintain at least 50% of the value of its portfolio (excluding cash and derivatives used for portfolio management techniques for the purpose of hedging, liquidity management and risk reduction) invested in Sustainable Investments.
2. With effect from 1 December 2024, the T. Rowe Price US Large Cap Growth Equity Fund will be renamed T. Rowe Price US Large Cap Growth Equity Net Zero Transition Fund, following a change to its investment policy that, as from the effective date, foresees that the promotion of environmental and social characteristics is done through the fund’s commitment to reduce the carbon footprint of the portfolio over the long-term, thereby contributing towards the goals of limiting global warming to 1.5° C. The fund will also maintain at least 50% of the value of its portfolio (excluding cash and derivatives used for portfolio management techniques for the purpose of hedging, liquidity management and risk reduction) invested in Sustainable Investments.

Re.: Important Notice: Changes made to the prospectus of the Select Investment Series III SICAV

Dear Shareholder,

We are writing to inform you of the following changes made to the prospectus of the Select Investment Series III SICAV in the October 2024 update.

- 1) Clarification of the investment policy and sustainability annex of the T. Rowe Price Global Growth Equity Net Zero Transition Fund, mainly with regards to Sustainable Investment, aligning it to our sustainable investment methodology.
- 2) Removal of the T. Rowe Price Japanese Equity Fund from the prospectus following its liquidation on 5 September 2024.
- 3) Reorganization of the Risk Descriptions section, clarifications and improvements of wording, grouping individual risks applicable to all sub-funds together as “Generic risk” and removing them from the “Main Risks” section on sub-fund pages. Management risk is renamed Conflict of interest risk, Liquidity risk is split into Market and Security liquidity risk, addition of Inflation and Default risk.
- 4) Addition of the “Net Zero Transition Contribution” section under the “Environmental, Social and Governance (ESG) Investment Policy” chapter.
- 5) Amendment of the “Investing in the funds” section, specifically the following:
 - “Types of Share Classes” and “Basic Share Class Designations” sections to include new share classes labelled B, C and E.
 - “Share class suffixes” to add 6 new suffixes labelled 4p, 6p, 8p, m, q and s.
 - Update of the share class designation and suffixes table to include the new share classes and suffixes.
 - New “Distribution Fee” section to clarify the purpose of the new B share class.
 - “Dividend Policy” section to clarify the purpose of the new 4p, 6p, 8p share class suffixes.
- 6) Update of the “Minimum transaction and balance amount” part of the fee table on all sub fund pages:
 - Decrease of the minimum Initial investment for I and S classes
 - Removal of the minimum Initial investment for A and Q classes
 - Removal of the minimum Additional investment for all classes
 - Removal of the minimum Redemption amount for A and Q classes
- 7) Update of the fee table of the T. Rowe Price Health Sciences Equity Fund to include the new share classes B, C and E.

- 8) General updates, amendments and clarifications of wording and any other changes driven by any applicable laws and regulations and/or by the regulator.

None of these amendments represent a material change to the investment strategy of any fund.
