Re.: Important Notice: Changes made to the Prospectus of the T. Rowe Price Funds SICAV

Dear Hong Kong Shareholder,

We are writing to inform you of the following changes made to the sub-funds (the "**Sub-Funds**") of the T. Rowe Price Funds SICAV (the "**Company**").

All capitalized terms used in this notice and not defined herein shall have the meanings ascribed to them in the existing Hong Kong Offering Document (comprising the Prospectus, Hong Kong Covering Document, and Product Key Facts Statements of the Sub-Funds).

- A. Changes which will take effect on 1 August 2024:
- 1) Removal of the minimum investment amount, minimum additional amount and minimum redemption amount for certain share classes of the Sub-Funds

The minimum initial investment/balance amount, minimum additional investment amount and the minimum redemption amount for all the A and Q share classes of the Sub-Funds are removed and updated as "Nil".

- B. Changes which have taken effect as of the date of this notice:
- 1) Enhancement of investment process of the Capital Allocation Income Fund

The investment process of the Sub-Fund is enhanced to clarify that the Sub-Fund may have exposure to certain asset classes or financial instruments where ESG factors are not considered as part of the investment decision-making process, as for example due to the type or nature of those financial instruments or asset classes.

2) Update of indicative swing factors

The indicative swing factors of certain Sub-Funds have been revised as detailed in the table below. As set out in the Prospectus, the indicative swing factors are estimates only and are reviewed on a regular basis. The indicative swing factor can change at any time.

3) Miscellaneous updates and changes

In addition to the above, miscellaneous updates/changes have been made to the Prospectus of the Company, which include:

- a) update to the list of share classes to include share classes "B", "C" and "E"1;
- b) update of the "Investing in the funds" section, specifically the following:
 - i) "Basic Share Class Designations" section to include new share classes labelled "B", "C" and "F"1.
 - ii) "Share class suffixes" to add 6 new suffixes labelled 4p, 6p, 8p, m, q and s;
 - iii) update of the share class designation and suffixes table to include the new share classes and suffixes;
 - iv) new "Distribution Fee" section to clarify the purpose of the new "B" share class1; and
 - v) "Dividend Policy" section to clarify the purpose of the new 4p, 6p, 8p share class suffixes;
- c) correction of the value for the possible aggregate exposure level to SU risks for US Smaller Companies Equity Fund;
- clarification of wording in the sustainability annexes following the change of methodology in the previous prospectus update; and
- e) other miscellaneous and editorial updates, changes, amendments and removal of obsolete disclosures.

These share classes are not offered or marketed in Hong Kong.

None of these changes, clarifications and enhancements represent a material change to the investment strategy of any of the Sub-Funds.

As usual, if you wish to transfer your investment to another fund or redeem your holding, you may do so at any time, as per the conditions set out in the prospectus, free of any charges.

The Hong Kong Offering Document, including the Sustainability annex which forms part of the Prospectus of the Company, will be updated to reflect the above changes, in due course. The Hong Kong Offering Document may be inspected free of charge at the office of the Hong Kong Representative during normal business hours.
