
## **Investment Objective & Strategy**

Uses a sampling strategy, investing substantially all of its assets in a broad spectrum of small-, mid-, and large-cap stocks representative of the S&P Total Market Index. Does not attempt to fully replicate the index by owning each of the stocks in it. The index includes over 4,000 stocks.
